If any lessee fails to comply with ALL of the terms set out in this contract, said lessee will be asked to leave the El Campo Civic Center, and the booth will be removed. **Full payment must be received and cleared for a booth to be assigned. If a vendor's check is returned, the vendor's booth will be forfeited immediately.**
